### **Standholders Agreement**

- Provision of security/staffing does not imply cover for any loss/damage to exhibitors stock however so caused.
- I understand that the insurance covered by the Organisers embraces only Public Liability and Employer's Liability.
- The signing of the booking form constitutes a contract. No deposit is required. Cancellation up to two calendar weeks. The Organiser reserves the right to charge the full price of the booking for any stand that is cancelled by a standholder at any time from cancellation date, if the space can not be re-let.
